## Introduction

The Ulster County Office for the Aging is pleased to provide this guide to services for our elderly. It is an attempt to consolidate in a single document a listing of available resources and programs for those who are living in our community and in good health, progressing through the moving into a setting which can provide services to meet their needs, in community-based home health care, assisted living, nursing homes, and hospice care.

This publication, *Caring for Our Seniors: A Guide to Programs and Services for Senior Care*, is a first step in compiling a comprehensive data base of services available to senior citizens in Ulster County.

It begins with a discussion of services and programs for Ulster County Senior Citizens who are living in the community who require minimal service to maintain their well-being, and progresses through home care, adult homes, assisted living, nursing homes to hospice care, either in home or in a hospital setting.

It is a living guide, subject to change as programs and services are added or removed. It is our hope that it will serve as a starting point for those of you who either need assistance for yourself or for a loved one.

The information in this guide has been carefully checked, and was current at the time of publication. However, since programs are often dependent on the funding stream, as well as volunteers and paid staff to implement them, it is recommended that you check with the program to determine if it still exists in unchanged format. For this reason, telephone numbers and, where possible, addresses are provided with each listing.

The staff of the Ulster County Office for the Aging is available, weekdays, between 9 a.m. and 5 p.m. to provide further assistance or help you with any questions you may have. You may reach them by telephone at (845) 340-3456, or by coming in to the office, which is located at 1003 Development Court, Kingston, NY 12401.

The *Guide* would be incomplete if it did not explain an exciting and challenging concept which is presently in the planning stage state-wide, which enable seniors, their families and caregivers to obtain a comprehensive long term care package from a single source. The program is called *Point of Entry*. The vision and explanation of that plan follows.

#### Long Term Care Program – Point of Entry

Throughout the state, the New York State Office for Aging and the Department of Health are working with local Offices for the Aging, Social Services and Health Departments to empower individuals to make informed choices and to streamline access to long-term care services. Long-term care services refers to the wide range of in-home, community-based and institutional services and programs that are designed to help the elderly and individuals with disabilities of all ages.

In Ulster County, the Office for the Aging, the Department of Social Services and the Department of Health have been working towards that goal for several years, and are currently designing a proposal to ensure that our elderly and disabled will be able to access the care they need with one central point of entry for all of the services they require.

The vision of the program is to provide an accessible, coordinated and personcentered long term care system that: supports self-determination and promotes personal responsibility; provides services that meet consumer needs; provides quality care, and provides efficiency and affordability.

There are multiple benefits of implementing a system that supports selfdetermination and promotes personal responsibility. It will:

- empower and create opportunities for consumers and their caregivers to make informed choices about their long-term care that balance cost, access and quality;
- be easy for consumers and their caregivers to understand and use;
- respect consumer choice by providing consumers and their caregivers with unbiased comprehensive information about available long-term care options and provider performance;
- be sensitive to consumer preferences and their willingness to assume personal risk; and,
- involve consumers and their caregivers in the planning, evaluation and decision making for long-term care, so that supports are guided at all levels by consumer needs and preferences.

The Point of Entry System is designed to provide services that meet consumer needs:

- supports social and physical wellness by keeping people functional and connected with their communities;
- makes comprehensive and coordinated service options available in a wide variety of settings;
- supports all persons to live as independently as possible as long as they desire and are able to do so; and,
- supports innovation through new delivery and flexible financing models, and through the use of technology.

The Ulster County Office for the Aging, a branch of Ulster County government since 1975, is part of a statewide network of local offices for the aging, and shares the same mission statement as the New York State Office for The Aging Agency:

It is the mission of the Ulster County Office for the aging to help older Ulster County residents to be as independent as possible through advocacy, development and delivery of cost-effective policies, programs and services which support and empower the elderly and their families, in partnership with the network of public and private organizations which serve them.

The Ulster County Office for the Aging is an umbrella agency, concerned with the physical, mental, emotional, financial and social well-being of county residents aged 60 and over.

OFA offers a wide range of services and programs, either directly, contractually, or through referral and/or recommendation to assist seniors as they progress along the continuum of care.

This guide has been designed to provide a comprehensive overview of those services which are available locally.

Many of the listings discuss services and programs which allow senior citizens to remain in their homes, living independently, or semi-independently, as long as possible.

When the need for care becomes greater than can be fulfilled at home, other alternatives are explored.

*Caring for Our Seniors* explains programs which the agency itself provides, and assists seniors, their families and caregivers to learn about other services available within the county. As you go through, you will find cross-references to other, related services which are also described in the guide. We encourage you to use the index, as well.

Staff at Ulster County Office for the Aging is available Monday through Friday from 9 a.m. until 5 p.m. to provide additional help, and you are welcome to call or visit.

Please note: all listings are current and available at the time of publication. However, services, locations and times are subject to change, and you are encouraged to call to ensure that the program information is still correct.

#### Service category: Case Management

Case Management is a comprehensive program which looks at the many facets of seniors' needs and problems, then works with the clients to set up a care plan to address the issues.

Ulster County Office for the Aging can provide case management to those senior citizens with physical and financial need.

These services include the Expanded in-Home Services for the Elderly Program, a uniform program of case management, non-medical in-home services, non-institutional respite and ancillary services, such as lifeline and safe return bracelets, for the elderly who need long term care, but are not eligible for Medicaid.

**How the process works:** Case managers meet with clients in their homes to discuss their desires, strengths and needs, and together, they set up a plan for action.

This includes incorporation of Office for the Aging direct services including home delivered meals, subsidized day care, personal care, home care or Lifeline.

The case manager assists the client to apply for entitlements such as SSI, Medicaid, Food Stamps, HEAP (Home Energy Assistance Program) funds if they have no one to assist them.

The case manager assesses the client's housing. If needed, the case manager assists the client to apply for or obtain home modification through the Resource Center for Accessible Living (RCAL) or applying for Senior Housing, if that is necessary.

The case manager works with families and caregivers to help incorporate them into the plan of care and prevent burnout. This includes Caregiver Support Groups facilitated by OFA.

The case manager assists clients either directly or through referral to obtain services from other agencies such as the Department of Social Services, Veterans' Administration, Lighthouse for the Blind and Visually Impaired and the Alzheimer's Association.

As the client needs a more protective environment, the case manager, assists the individual to obtain placement in an assisted living facility or nursing home. The case manager will also assist the client to apply for chronic care Medicaid, and to obtain the

PRI (Patient Review Instrument) required for placement in most facilities if they have no one to assist them. For more information, call (845) 334-5125.

#### Service category: Financial Counseling and Tax Preparation

Appointments are available for free tax counseling and tax preparation for Ulster County residents who are disabled or age 60 and over.

The program is administered by the AARP (American Association of Retired Persons) volunteers who have been trained in basic, intermediate and advanced tax preparation.

The program is designed to assist persons with low and medium income, and volunteers are able to prepare both non-itemized and itemized tax forms, including Schedules A, B and D. They are also able to file returns electronically.

This program is held at several locations throughout Ulster County, on an appointment only basis. In addition to the Office for the Aging site, churches and libraries throughout the county host the program.

The service is available from February 1 through mid-April of each year. For information about sites, or to make appointments, call the Office for the Aging at (845) 340-3486.

#### Service category: Health Screenings and Physical Well-being

## **Care-A-Van:**

The Ulster County Office for the Aging provides a regular schedule of free health screening and education programs throughout the county through a specially equipped 40 foot van staffed with a registered nurse.

The purpose of the Care-A-Van is to promote good health, to prevent health-related problems through education, provide early detection and to inform seniors and connect them with available community services.

The services provided by the Care-A-Van do not replace regular visits to your own physician. Visits to the Care-A-Van should be made between regular doctor visits to check on your current health status and to receive information and education on health care.

The following early detection and screening tests are provided free of charge to all Ulster County residents aged 60 and over:

- Blood Glucose (diabetes)
- Health Inventory (height, weight and medical inventory)
- Hemoglobin (blood test to measure iron/anemia)

- Stool Guaiac Kits (checks for blood in stool specimens)
- Urine Screening
- Vision

The van operates from April 1 to December 15 on scheduled weekdays from 10 a.m. to 2 p.m. The schedule of dates and locations is available on the Ulster County Office for the Aging website, <u>http://www.co.ulster.ny.us/aging/careavan.htm</u>, in S.C.A.N. (the free county-wide newspaper for seniors), the Senior Gazette, local newspapers and senior clubs. Appointments are not necessary.

## **Physical activity programs:**

Each year, the Ulster County Office for the Aging sponsors Senior Games in May.

Lunch-site Physical Activity Program: these programs are held, on a regular basis, at Senior Dining Sites.

Physical activity and exercise programs have several benefits for senior citizens.

- Increased agility and sense of balance prevent falls and subsequent broken bones.
- Exercise is good for the heart and can help to lower blood sugar for diabetics
- The programs provide companionship and mental stimulation

The Ulster County Office for the Aging, in conjunction with the Community Heart Health Coalition, the Ulster County Health Department and corporate donations, has been fortunate to maintain a regular series of physical activity programs at lunch sites throughout the county. Information about days and times can be obtained by calling the Office for the Aging at (845) 340-3486.

## Service category: Home Care

For those seniors who are able to remain at home, but require help to do so, the Ulster County Office for the Aging maintains a registry of Nursing and Homemaker Service Providers.

Services are provided to those people with temporary or chronic needs who cannot perform day to day tasks, and range from assistance in shopping, meal preparation, laundry and other household tasks, as well as bathing and grooming.

They all charge a set hourly fee. For more information about the specific services provided by an agency, call the agency directly.

#### Service category: Home Heating Services/Weatherization Assistance

For senior citizens on fixed incomes, the cost of paying heating bills and maintaining safe, affordable energy-efficient homes can be daunting.

The Ulster County Office for the Aging may be able to assist with the following two programs.

• <u>Home Energy Assistance Program (HEAP)</u>: The Home Energy Assistance Program provides funding to help pay heating bills for low-income individuals age 60 and over.

Eligibility – Applicants must pay for heat directly, or pay for heat in their rent payment, live in a HEAP-eligible residence, is US citizens or Qualified Aliens. Tenants of government-subsidized housing where heat is included in the rent, or residents of congregate care facilities, dormitories, group homes or institutions are not eligible.

Income Limits – Recipients of public assistance, food stamps or SSI are incomeeligible for HEAP. All other applicants must meet the gross monthly income test based on household size. These limits are set each heating season. Call the Office for the Aging at (845) 340-3006 to see if you qualify.

Applying – You can begin applying for a HEAP grant in October or November each year. HEAP provides grants on a first-come, first-served basis until the funds provided for each heating season run out. If you received HEAP in the past year from the Ulster County Office for the Aging, you will automatically receive a HEAP application for the present year.

• <u>Weatherization Referral and Packaging Program (WRAP</u>: WRAP offers a variety of services and resources to low income, vulnerable elderly to assist them in maintaining safe, affordable, energy-efficient homes

Eligibility – Applicants must be full-time Ulster County residents over the age of 60, and be responsible for their own heating costs.

Call the Office for the Aging at (845) 340-3006 for more information.

## Service category: Legal Services

Legal counseling on civil matters is available to Ulster County residents aged 60 and over, provided by an attorney admitted to the practice of law in New York State by

appointment only. Counseling on criminal matters is not available through the Ulster County Office for the Aging. Among the services available are:

- Drawing of wills
- Landlord and tenant problems
- Powers of attorney
- Preparation of health care proxies and living wills
- Asset protection counseling
- Preparation of deeds
- Consultations regarding guardianships
- Review of leases
- Consultations regarding elder law issues
- Property disputes

Appointments are limited to <sup>1</sup>/<sub>2</sub> hour, and appointments must be made in advance. Call (845) 340-3577) to make an appointment. Contributions are accepted, but not required.

## Service category: Long-Term Care Ombudsman Program

The Long Term Care Ombudsman Program is a federal advocacy and education program dedicated to protecting people living in long term care facilities. In Ulster County, the program is a partnership of the Office for the Aging and Hands On! The Hudson Valley.

A certified Long Term Care Ombudsman is a professionally trained and certified advocate who resolves issues with long term care facilities on behalf of residents and their families.

The purpose of the Ombudsman Program is to educate the community and residents about residents' rights, and to improve the quality of life and care for residents of residential health facilities and nursing homes by confidentially receiving, investigating and resolving residents' problems and complaints.

The obligations of the Ombudsmen include:

- confidential complaint receipt and resolution,
- protection of resident rights
- identification of adverse conditions affecting residents
- providing information, and
- making referrals on behalf of residents and their families.

Ombudsmen visit each facility at least once every week, although, in Ulster County, they generally visit two or three times a week. Every facility has signs prominently posted with the New York State Ombudsmen Hot Line telephone if immediate attention to a problem is required.

### Service category: Medical Insurance and Medicare Counseling

There have been sweeping changes to the Medicare program, which now provides coverage for prescription drugs under Medicare Part D. Within Ulster County, senior citizens may choose from many different plans, all of which provide different coverage, and each of which has its own monthly premium.

Selecting the right plan requires a great deal of thoughtful consideration of the various available options.

The Ulster County Office for the Aging offers individualized information and guidance about plans available in the area through HIICAP (the Health Insurance Information, Counseling and Assistance Program).

Local counselors have received structured training which covers all aspects of Medicare, Medicare Part D, Medicaid, Social Security/Medicare and Medigap Insurance and EPIC.

Their assistance is available at no charge to any Ulster County senior citizen. It requires an appointment which will last at least one hour. Because of the complexity of the service, appointments are necessary.

Those wishing to make an appointment with the Ulster County Office for the Aging may do so by calling (845-340-3456).

Prior to your appointment, you will need to gather the following information:

- 1. Any papers received in the past year from Social Security
- 2. Your Medicare Card
- 3. Your EPIC card, if you have one
- 4. Your Medicaid card, if you have one
- 5. Your private insurance card, if you have one
- 6. a list of every prescription medication you take, including exact prescription information regarding name of medication, dosage and frequency of use.

It is extremely important for you to provide this information, because the Office For the Aging does not have access to any personal information about you through the Social Security website. Your information is totally confidential.

An Ulster County Office for the Aging counselor will use the information you provide, along with the Social Security Medicare website to find several possible choices based on the individual's needs. The information will include the monthly premium, restrictions, which medications are covered, and which local pharmacies accept the plans, as well as an estimated yearly cost, based on the number of prescription medications used.

#### Service category: 911 Senior Safety Cell Phones

Cell phones which have been donated by community members to the Office for the Aging are programmed for 911 only service. These phones are distributed to any Ulster County resident aged 60 and over who request one. They are free, and there is no service or maintenance cost.

To request a cell phone, please call the Office at (845) 340-3456, or stop in to at 1003 Development Court, Kingston, NY.

#### Service category: Nutrition Programs

<u>Senior Dining Sites</u>: Office for the Aging operates five Senior Dining Sites throughout the county, which offer nutritious, hot meals every weekday from 11 a.m. until noon. They also provide an opportunity to socialize with others who have similar interests.

- **Guidelines:** Please call the site between 10 a.m. and noon the day before you plan to attend in order to be sure there are enough meals for everyone. A sign-up sheet is also available at the site to reserve your meal for the next day.

If you have reserved your meal, but cannot attend, please call the prior to the day of the lunch you wish to cancel.

- Eligibility: You must be an Ulster County resident aged 60 or over.
- **Cost:** There is no set cost, but a suggested donation of \$2.25 or \$11.25/week is requested to help defray the cost of the program. Cash, checks or money orders are accepted.
- **See also:** *Congregate Meal Sites in Section B of this guide.*

Home Delivered Meals: The Office for the Aging can provide Home Delivered Meals to homebound residents of Ulster County aged 60 and over if they are unable to prepare their own meals or have meals prepared for them.
 Hours of Operation: Meals are generally delivered between the hours of 10:30 and 1 p.m., Monday through Friday. No delivery on holidays or during adverse weather conditions. Shelf-stable meals are provided in advance for use on such occasions.
 To Apply: Anyone may make a referral by calling the OFA Central Intake number, (845) 334-5125 and giving essential information such as address, telephone number, medical

contact and reason for requesting meals.

	A home visit by the Office for the Aging or the Department of Social Services caseworker is required before the start of delivered meals.
Cost:	A donation of \$2.25 is requested.

Nutrition Counseling:	Nutrition counseling and assistance with meeting the needs of a special diet is available at the dining sites or in your home by a Registered Dietician. For information, call the Office for the Aging at (845) 340-3456.

#### Service category: Senior Citizen ID Cards

For those who do not drive, and require photo identification cards that may be used for proof of identify (such as when cashing checks), or proof of age (to receive discounts of goods or services where offered), the Ulster County Office for the Aging issues photo identification cards.

This card may not be acceptable proof of identity for air travel, so please be sure to inquire with your airline. If you do need a 'non-driver's license' identity card, you will need to obtain one from the Ulster County Clerk's Motor Vehicles Division.

They are issued at the Office, located at 1003 Development Court, Kingston. You must come into the office in person with proof of your date of birth and have your picture taken for the card. Cards are not necessarily issued the same day. Please contact the Office at (845) 340-3456.

#### Service category: Transportation Services

Once week subsidized transportation is available to Ulster County Seniors aged 60 and over. Medical transportation is also available by appointment Monday through Friday.

## Section B: Services and Programs Available Within Ulster County

## Service category: Medical Insurance and Medicare Counseling

### **Program Name: Medicare**

## **Telephone number:** 1- 800 MEDICARE (633-4227)

Medicare is a Health Insurance Program for;

- People 65 years of age and older
- Some people with disabilities under the age of 65
- People with End-Stage Renal Disease (permanent kidney failure requiring dialysis or a transplant.

Medicare has traditionally had two parts, and very recently has added an expanded program which covers prescription drugs:

- Part A (Hospital Insurance) Most people do not have to pay for Part A
- Part B (Medical Insurance) Most people pay for Part B
- Part D (Prescription Drug Coverage) Most people pay for Part D

### Part A: (Hospital Insurance)

**Helps pay for**: care in hospitals as an in-patient, critical access hospitals (small facilities that give limited outpatient and inpatient services to people in rural areas), skilled nursing facilities, hospice care, and some home health care.

**Cost:** Most people get Part A coverage automatically when they turn age 65. They do not have to pay a monthly premium for Part A because they or a spouse paid Medicare taxes while they were working.

If you (or your spouse) did not pay Medicare taxes while you worked and you are age 65 or older, you still may be able to buy Part A coverage. If you are not sure you have Part A, look on your red, white and blue Medicare card. It will show "Hospital Part A" on the lower left corner of the card. You can also call the Social Security Administration toll free at 1-800-772-1213, or call or visit your local Social Security office for more information about buying Part A. If you get benefits from the Railroad Retirement Board, call your local RRB or 1-800-808-0772.

#### Part B (Medical Insurance)

**Helps pay for:** Doctors' services, outpatient hospital care, and some other medical services that Part A does not cover, such as the service of physical and occupational therapists, and some home health care. Part B helps pay for those covered services and supplies when they are medically necessary.

**Cost:** You pay the Medicare Part B premium. In 2006, the amount is \$88.50. In 2007, the amount may change. In some cases, this amount may be higher if you did not choose Part B when you first became eligible at age 65. The cost of Part B may go up 10% for each 12-month period that you were eligible for Part B and did not sign up for it, except in special cases. You will have to pay this extra 10% for the rest of your life.

Enrolling in Part B is your choice. You can sign up for Part B any time beginning 3 months before you turn 65. Please call the Social Security Administration at 1-800-772-1213 or visit your local Social Security office to sign up. If you choose to have Part B, the premium is usually taken out of your monthly Social Security, Railroad Retirement or Civil Service Retirement payment. If you do not get any of the above payments, Medicare sends you a bill for your Part B premium every 3 months. You should get your Medicare premium bill by the 10<sup>th</sup> of the month. If you do not get your bill by the 10<sup>th</sup>, call the Social Security Administration at 1-800-772-1213 or your local Social Security office If you get benefits from the Railroad Retirement Board, call your local RRB or 1-800-808-0772.

**Eligibility:** Generally, you are eligible for Medicare if you or your spouse worked for at least 10 years in Medicare-covered employment and you are 65 years old and a citizen or permanent resident of the United States. You might also qualify for coverage if you are a younger person with a disability or with End-Stage Renal disease (permanent kidney failure requiring dialysis or transplant).

<u>Part D (Prescription Drug Coverage)</u>: There have been sweeping changes to the Medicare program, which now provides coverage for prescription drugs. Within Ulster County, senior citizens may choose from many different plans, all of which provide different coverage, and each of which has its own monthly premium.

Selecting the right plan requires a great deal of thoughtful consideration of the various available options.

The plans are not income-based; however, some seniors whose income is very low, may be eligible for low-cost insurance.

There are several ways to obtain information about the plans and program.

• Ulster County Office for the Aging: The agency offers individualized information and guidance through HIICAP (the Health Insurance Information, Counseling and Assistance Program) about the plans available in Ulster County. Local counselors have received structured training which covers all aspects of Medicare, Medicaid, Social Security/Medicare and Medigap Insurance. Their assistance is available at no charge to any Ulster County Senior Citizen. It requires an appointment which can take an hour or more to complete. Because of the complexity of the service, and the availability of counselors, walk-in's are not encouraged and may have to come back at another time for an appointment.

Those wishing to make an appointment with the Ulster County Office for the Aging may do so by calling (845-340-3456).

Prior to your appointment, you will need to gather the following information:

- 1. Any papers received in the past year from Social Security
- 2. Your Medicare Card
- 3. Your EPIC card, if you have one
- 4. Your Medicaid card, if you have one
- 5. Your private insurance card, if you have one
- 6. A list of every prescription medication you take, including exact prescription information regarding name of medication, dosage and frequency of use.

It is extremely important for you to provide this information because the Office for the Aging does not have access to any personal information about you through any source such as Social Security or Medicare.

Your information is totally confidential.

An Ulster County Office for the Aging counselor will use the information you provide, along with the Social Security Medicare website to find the several best possible choices based on the individual's needs. The information will include the monthly premium, restrictions, what medications are covered, and what local pharmacies accept the plans, as well as an estimated yearly cost, based on the number of prescription medications used.

- CMS, the Center for Medicare and Medicaid Services, has published a guidebook about the programs, maintains a website, an automated telephone line, and has local representatives who can assist you. CMS is the official source of information about the plans available.
  - 1. *Medicare and You* is updated and reprinted each year. It is mailed to everyone enrolled in Medicare at the time. If, however, you did not receive a copy or have misplaced your copy, you can obtain a replacement. If the guide is revised during the year, the revised and/or updated information is available on the Medicare website, by calling 1-800-Medicare and through the Ulster County Office for the Aging *Health Insurance Information, Counseling and Assistance Program (HIICAP).*
  - 2. The official CMS/ Medicare website at <u>www.medicare.gov</u> has a comprehensive overview of Medicare A, B and D (Part D is the prescription drug plan coverage program).

- 3. Call Medicare at 1 (800) 633-4227. This is a programmed, voice-activated system, which is available 24 hours a day. If you wish to speak with a live representative, the waiting time has been greatly reduced.
- 4. You can arrange to visit your local Office for Aging HIICAP office located at 1003 Development Court in Kingston by calling (845) 340-3456 for an appointment.
- **Insurance Plans which provide coverage in New York State:** all of the agencies have computer websites, send out mailings, provide information through pharmacies and advertise in newspapers and magazines, particularly those of interest to senior citizens.
- **Pharmacies** can provide you with both written information and guidance from a pharmacist about the prescription plans which they cover. Not all pharmacies cover all plans.
- AARP (American Association of Retired Persons): This Senior Citizen organization has produced brochures and advertisements with information about the Medicare Part D plan, and devotes a significant amount of its internet resources to providing more detailed information. AARP has a prescription drug plan of its own.

## **Program Name: EPIC (Elderly Pharmaceutical Insurance Coverage Program)**

For many years, New York State has maintained a program for residents aged 65 or older which assists seniors in paying for prescription drugs. It is an income-based program. In 2006, single people with annual incomes under \$35,000, or married persons with combined incomes of \$50,000 are eligible to join.

The plan covers almost all prescription drugs, insulin and insulin syringes.

Most New York State pharmacies accept EPIC.

There are two EPIC plans:

- The annual **Fee Plan** for single seniors with annual incomes of \$20,000 or less; married couples with joint incomes no higher than \$26,000. The annual fee schedule is enclosed in a chart which accompanies the application form. In addition to the annual fee, enrollees pay a co-pay for each prescription which ranges from \$3 to \$20, depending on the total cost of the prescription.
- The **Deductible Plan** for single seniors with annual incomes between \$20,000 and \$35,000; married couples with joint incomes between \$26,000 and \$50,000. This plan has no annual fee. Enrollees pay full price for their prescriptions until they meet their annual deductible; once that is met, they pay a co-payment that ranges from \$3 to \$20. The annual

deductible is based on income. Enclosed with the Plan's enrollment application is a chart detailing the Deductible Schedule.

These application forms and additional information about the EPIC plan are available by calling 1-800-332-3742, or from the Ulster County Office for the Aging.

Beginning in January 2006, the Medicare prescription plan coverage took effect. Dual enrollment in both EPIC and a Medicare Part D plan can provide additional assistance with paying for the cost of prescription medications.

## Program name: Extra Help

If your income is below a certain level (\$12,920 for single persons; \$17,321 for married couples), and your resources are limited, you may qualify for the Extra Help program.

With this program, you will not pay a premium or deductible for your Medicare drug coverage, and will only pay a co-payment of \$2 for generic drugs and \$5 for brand-name drugs.

Social Security mailed applications for Help with Medicare Prescription Drug Plan Costs to persons who may be eligible. If you did not receive this application, or have misplaced it, you can get another copy by calling Social Security at 1-800-772-1213, or from the Ulster County Office for the Aging. For assistance in completing the Low Income Assistance (as this help is called) contact the Social Security Office. Social Security representatives can input your information into the computer immediately and the waiting time to receive your approval information is usually shorter.

## Program Name: Medicaid

What is Medicaid? Medicaid is a program for New Yorkers who can't afford to pay for medical care.

Who qualifies for Medicaid? You may be covered by Medicaid if:

- You have high medical bills
- You receive Supplemental Security Income (SSI)
- You meet certain income, resource, age, or disability requirements.

Income and resource requirements are subject to yearly adjustments. You may also own a home, a car and personal property, and still be eligible.

In order to determine if you qualify, please call the Ulster County Department of Social Services Medicaid telephone number at (845) 334-5045 to set up an appointment. If you are home-bound, call Ulster County Department of Social Service to find out how you can apply without visiting the office. Senior citizens may also call the Ulster County Office for the Aging at (845) 340-3456 to receive help with application and eligibility.

What does Medicaid cover: In general, the following services are paid for by Medicaid, but some may not be covered for you because of your age, financial circumstances, family situation, transfer of resource requirements, or living arrangements. Some services have small co-payments. These services may be provided using your Medicaid card or through your managed care plan if you are enrolled in managed care. You will not have a co-pay if you are in a managed care plan.

- smoking cessation agents
- treatment and preventive health and dental care (doctors and dentists)
- hospital inpatient and outpatient services
- laboratory and X-ray services
- care in a nursing home
- care through home health agencies and personal care
- treatment in psychiatric hospitals (for persons under 21 or those 65 and older), mental health facilities, and facilities for the mentally retarded or the developmentally disabled
- medicine, supplies, medical equipment and appliances (wheelchairs, etc.) Under new federal legislation, effective January 1, 2006, Medicare, not Medicaid, will be the primary payer of prescription drugs for dual eligible recipients (persons who qualify for both Medicare and Medicaid).
- clinic services
- transportation to medical appointments, including public transportation and car mileage
- emergency ambulance transportation to a hospital
- some insurance and Medicare premiums
- other health services

If you are eligible for Medicaid, you will receive a Benefit Identification Card which must be used when you need medical services. There may be limitations on certain services.

For you to use your Benefit Identification Card for certain medical supplies, equipment or services (for example, wheelchair, orthopedic shoes, transportation) you or the person or facility that will provide the service must receive approval before the service can be provided (prior approval).

<u>Types of Medicaid programs available</u>: Ulster County provides two comprehensive Medicaid programs:

- Fee-for-service Medicaid, in which some services require a small copayment; and
- Managed Care Medicaid. Enrollment in a Medicaid managed care program through a Health Maintenance Organization (HMO) is an Ulster County option.

When you join a managed care program, you will choose a personal doctor who will be responsible for making sure all your health care needs are met. The doctor will send you to someone else if you need more help than he or she can provide.

Managed care covers most of the benefits recipients will use, including all preventive and primary care, inpatient care and eye care. People in managed care plans use their Medicaid benefit card to get these services that the plan does not cover.

<u>Information about keeping assets if you are in a nursing home or intermediate care</u> <u>facility:</u> Medicaid allows a recipient to keep a small amount of income for personal needs. You can also keep some of your income for your family if they are dependent on you. A spouse who remains in the community may also keep resources and income above the allowable income levels. You may call the Ulster County Medicaid Division at (845) 334-5170 for additional information or clarification.)

<u>Will there be a legal claim (lien) placed on my estate (assets) when I die?</u> If you receive medical services paid for by Medicaid on or after your 55<sup>th</sup> birthday, or when permanently residing in a medical institution, Medicaid may recover the amount of the cost of these services from the assets in your estate upon your death.

#### Service category: Vision and Eyeglasses

Generally, Medicare does not cover routine eye care and most eyeglasses or contact lenses. You are required to pay 100% of the cost of routine eye care or eyeglasses. However, the cost of one pair of eyeglasses with standard frames after cataract surgery that includes implanting an intraocular lens is covered.

However, following cataract surgery with an intraocular lens, Medicare helps pay for cataract glasses, contact lenses, or intraocular lenses provided by an ophthalmologist. Services provided by an optometrist may be covered, if the optometrist is licensed to provide this service in New York state.

- Only standard frames are covered
- Lenses are covered even if you had the surgery before you had Medicare
- Payment may be made for lenses for both eyes, even though cataract surgery involved only one eye.

Cost to you: You pay 20% of Medicare-approved amounts for one pair of eyeglasses or contact lenses after each cataract surgery with an intraocular lens. You pay any additional cost for upgraded frames.

Important notes:

- You must pay an annual \$124 (in 2006) deductible for Part B services and supplies before Medicare begins to pay its share.
- Actual amounts you must pay may be higher if a doctor, health care provider, or supplier does not accept assignment.
- If you choose to purchase "upgraded frames," your supplier should ask you to sign an Advance Beneficiary Notice (ABN) informing you that you will be required to pay the difference in the cost for the "upgraded frames" and the Medicare-approved amount for "standard frames."
- If you choose to purchase "upgraded frames," your supplier is required to submit claims to Medicare, indicating the purchase of the "upgraded frames" as two separate line items on the claim. The supplier will use code V2020 for the cost of the "standard frames" (the Medicare-approved amount) and code V2025 for the difference between the charges for the "deluxe frames" and the "standard frames" (the amount you are required to pay). These codes will appear on the Medicare Summary Notice (MSN) you receive. Code V2025 will appear on your MSN as a non-covered charge.

There are programs and services available within Ulster County which can help you with the cost of eye examinations, surgery, eyeglasses, adaptive equipment and learning to adjust to loss of vision.

#### Service category: Speech and Hearing

Medicare does not cover routine hearing examinations or hearing aids. You are required to pay 100% of the cost of routine hearing exams or hearing aids.

In some cases, diagnostic hearing exams are covered by Part B. You will pay 20% of Medicare-approved amount for diagnostic hearing exams. In 2006, you must pay an annual \$124 deductible for Part B services and supplies before Medicare begins to pay its share. It is important for you to understand that the actual amount you must pay can be higher than 20% if a doctor, health care provider or supplier does not accept Medicare assignment.

There are two programs within Ulster County that may be able to help you with the cost of hearing examinations and/or hearing aids, as well as adaptive equipment (for example, an alarm clock that operates by flashing lights, rather than sound to awaken you).

#### Service category: Senior Citizen Housing

Within Ulster County, there are several rental housing units for Senior Citizens. Some are exclusively for Seniors, while others also have a number of apartments for handicapped persons of any age. It is important to know that Senior Citizen Housing is not necessarily handicapped-accessible, so if you have special needs, please inquire.

This guide lists only sites which have some sort of government subsidy, under the general term of "affordable housing." Because the complexes were given approval under various programs, the subsidies and the terminology vary from one to another, so you will need to check the eligibility guidelines for each.

They include no supportive services or staffing to address the special needs of aging residents. This housing is not licensed by a government agency, but subsidized housing may be supervised by a government housing agency.

Generally speaking, these apartments have waiting lists, and it is a good idea to apply ahead of time if you are thinking of moving into an apartment. They are arranged alphabetically by the name of the apartments, not by geographic location.

	This includes incorporation of Office for the Aging direct services including home delivered meals, subsidized day care, personal care, home care or Lifeline.
	The case manager assists the client to apply for entitlements such as SSI, Medicaid, Food Stamps, HEAP (Home Energy Assistance Program) funds if they have no one to assist them.
	The case manager assesses the client's housing. If needed, the case manager assists the client to apply for or obtain home modification through the Resource Center for Accessible Living (RCAL) or applying for Senior Housing, if that is necessary.
	The case manager works with families and caregivers to help incorporate them into the plan of care and prevent burnout. This includes Caregiver Support Groups facilitated by OFA.
	The case manager assists clients either directly or through referral to obtain services from other agencies such as the Department of

	Social Services, Veterans' Administration, Lighthouse for the Blind and Visually Impaired and the Alzheimer's Association. As the client needs a more protective environment, the case manager, assists the individual to obtain placement in an assisted living facility or nursing home. The case manager will also assist the client to apply for chronic care Medicaid, and to obtain the PRI (Patient Review Instrument) required for placement in most facilities if they have no one to assist them.

# Service category: Adult Day Care Centers

There are two types of adult day care centers as defined by the New York State Department of Health: the medical model which provides medical monitoring, counseling, therapy and activities; and the social model, which provides socialization, supervision and activities. It offers respite to family members and caregivers, as well as providing a supervised setting when caregivers are at work or away during the day time.

Within Ulster County, there are currently one medical model day care programs (Ten Broeck Commons in Lake Katrine) and three social model day care programs (Canal Lodge Adult Day Care Center in Ellenville, Greenkill Avenue Day Care Center in Kingston, and Multi-County Community Development Adult Day Services in Highland). More detailed information about each program follows.

#### Service category: Home Care, Short and Long Term

For many seniors whose health is beginning to decline, living at home is a viable and less costly alternative than moving into a nursing home. It does, however, require the assistance and support of programs and services to ensure that needs are being met.

Within Ulster County, there are several programs that can help. Care can range from household tasks to skilled nursing services. This guide will discuss those which the Ulster County Office for the Aging has contracts, and maintains a record of licensure and inspections by state agencies. Each listing will describe the services available through the specific agency. Not all agencies provide every service. For this reason, it is often advisable to work through the Office for the Aging or a Certified Home Health Agency, which can coordinate a care plan and make the appropriate arrangements. (Programs of the Office for the Aging and Certified Home Health Agencies are described more fully in this chapter of the guide.)

### Definition of terms used:

<u>Case management</u> – coordination of a client/patient's health care services to ensure appropriate, quality care as their health care and social needs change.

<u>Certified home health aide</u> – paraprofessional caregivers through New York Stateapproved programs provide hands-on personal care, expanded health related tasks when trained and supervised by a Registered Nurse, and light home-making tasks.

<u>Companion aide</u> – provides companionship for a client/patient and assistance with tasks such as homemaking, meal planning and preparation, shopping and transportation.

<u>Homemaker</u> – provides assistance with domestic tasks such as light housekeeping, laundry, shopping and meal preparation.

<u>Licensed practical nurse</u> – provides a broad range of nursing services, including administration of prescription medicines, insulin injections and monitoring of vital signs.

<u>Nutrition educator</u> – provides nutritional services to the client/patient as prescribed by the physician, including nutrition assessment, and counseling to meet normal and therapeutic needs.

<u>Occupational therapist</u> (OT)– performs diagnostic tests, measurements and evaluations, such as mobility of joints, strength and endurance of muscles. Initiates and applies appropriate prevention, therapeutic and rehabilitative occupational therapy procedures and techniques.

<u>Personal care aide (PCA)</u> – trained paraprofessional assists sick or disabled individuals with personal care and homemaking tasks.

<u>Physical therapist (PT)</u> – performs diagnostic tests and evaluations such as joint mobility, stability and appearance of walking, strength and muscle endurance.

<u>Registered nurse (RN)</u> – performs all nursing functions including the most highly technical procedures, such as caring for clients/patients on ventilators or providing home infusion therapy. Performs client/patient assessments, initiates nursing services and makes appropriate referrals. Takes the role of case manager in a certified agency.

<u>Respiratory therapist (RT)</u> – employs specific testing techniques to assist in diagnosis, monitoring and treatment of those with respiratory problems. Provides respiratory rehabilitation, appropriate instruction and supportive counseling for the client/patient and family.

<u>Speech therapist</u> – assesses and evaluates client/patient's needs for speech, language and/or auditory services. Initiates and applies appropriate preventive, therapeutic and rehabilitative procedures and techniques.

#### Service category: Nursing and Homemaking Service Providers

For those seniors who are able to remain at home, but require help to do so, there are several local Nursing and Homemaker Service Providers. Services are provided to those people with temporary or chronic needs who cannot perform day to day tasks, and range from assistance in shopping, meal preparation, laundry and other household tasks, as well as bathing and grooming. Not all agencies provide all services. It is important that, before you select a provider, you know exactly what services are required and determine if a single agency can accommodate all of these needs.

For more information about the specific services provided by an agency, call the Office for the Aging at (845) 334-5125, or call the agency directly.

They all charge a set hourly fee, and that fee may vary, depending upon both the agency and the services required.

### Service category: Certified Home Health Agencies

Program definition	<ul> <li>Certified Home Health Agencies (CHHAs) provide part-time, intermittent health care and support services to individuals who need intermediate and skilled health care.</li> <li>CHHAs can also provide long-term nursing and home health aide services, can help patients determine the level of services they need, and can either provide or arrange for other services including physical, occupational and speech therapy, medical supplies and equipment, and social worker and nutrition services.</li> </ul>
Eligibility:	Services provided by CHHAs may be reimbursed by Medicare, Medicaid, private payment and some health insurers.
How accessed:	Referrals to CHHAs may come from sources including physicians or hospital discharge planners, or the patient can look for visiting nurse providers in the telephone book. This guide provides information about the three Ulster County- based Certified Home Health Agencies. The Ulster County Department of Social Services contracts with these agencies to provide services.
Services:	Please check carefully with each agency, because not all of them provide all services.
Oversight:	<i>The New York State Department of Health</i> licenses Certified Home Health Agencies, and has in place regulations to ensure that staff are appropriately qualified, trained and supervised. Unannounced surveys by the state assess CHHAs' compliance standards governing the quality and scope of services.

# Service category: Community-Based Long Term Care

# Overview:

Long term care services may include the medical, social, housekeeping, or rehabilitation services a person needs over months or years in order to improve or maintain function or health. Such services are provided not only in nursing homes, but also in patients' homes or in community-based settings such as assisted-living facilities.

New York State has many services and programs as alternatives to nursing home care. Both medical and non-medical care may be received at home or in residential settings, and can range from simple (light housekeeping) to complex (nursing care or physical therapy) services.

These services may be accessed through private health insurance, a managed care agency, Medicaid or Medicare, depending on financial and medical eligibility, and meet the criteria of the service or program; or they can be assessed by those who are able to pay privately.

• However, while some services are available to persons who are eligible for Medicaid, have Medicare coverage, use their own funds ("private pay"), have private health or long term care insurance, some services are available *only* to persons who are eligible for Medicaid.

# Service category: Long Term Home Health Care Program

Program definition	<ul> <li>The Long Term Home Health Care Program is a coordinated plan of medical, nursing and rehabilitative care provided at home to disabled persons who are medically eligible for placement in a nursing home. It offers an alternative to institutionalization.</li> <li>The program offers a coordinated network of professional and supportive health and social services.</li> <li>The program is designed to enrich and reinforce the person's self- care capabilities within his/her home environment.</li> </ul>
Eligibility:	This program is available to individuals who are medically eligible for placement in a nursing home and choose to receive services at home. These individuals must have care costs which are less than the nursing home cost in the county.
How accessed:	Individuals can access this program through a referral from the Ulster County Office for the Aging, the hospital discharge planner, the Ulster County Department of Social Services, or a Long Term Home Health Care Provider. The county determines eligibility for the program, and the Ulster County Department of Social Services authorizes all services that are provided.
Services:	All regular Medicaid services are provided, and the following services may also be available:
	<ul> <li>Case management by Registered Nurses (RNs)</li> <li>Home delivered or congregate meals</li> <li>Housing improvements and moving assistance</li> <li>Respiratory therapy</li> <li>Medical social services, nutrition and dietary services</li> <li>Respite care, social day care and social transportation.</li> </ul>
Oversight:	<i>The Ulster County Department of Social Services</i> is responsible for participating in the periodic reassessment of the services provided. <i>The provider agency</i> is responsible for obtaining physician orders and administering the assessment tools. <i>The New York State Department of Health</i> periodically surveys the providers to determine the quality and scope of the medical, nursing

# Section C: When It Is No Longer Possible To Remain At Home

# Senior Citizen Housing: Lease Termination

There are times when senior citizens find it necessary to move due to changes in their health or financial situations. They may have signed lease arrangements which they are reluctant to break because of penalties in those contracts. New York State has very specific laws regulating and permitting lease termination for senior citizens.

Section 227(a) of New York State Real Property Law spells out the rights of people aged 62 and over to terminate a residential lease or rental agreement before the specified time period ends, and Section 227(a) specifies the conditions under which the termination can take place.

Terminating a lease according to the stipulations of Section 227(a) is a legal termination and is not a lease violation.

This law applies to any type of building or property that the older person is occupying for dwelling purposes (is living there).

This law applies to any leaseholder (the person whose name is on the lease) who is aged 62 or older, or who will become aged 62 during the term of the lease or rental agreement. The law also applies to the leaseholder's husband or wife who is aged 62 or older or who will become aged 62 during the lease's term.

When the lease is terminated, the tenant no longer is responsible for making rent payments to the landlord.

An older tenant can terminate the lease or rental agreement to move into any of the following types of living arrangements;

- Adult Care Facility (four types, commonly known as an Adult Home, Enriched Housing Program, Family Type Home or Residence for Adults);
- Nursing Home;
- Subsidized housing (senior housing or housing meant for tenants of all ages;
- Less expensive senior housing; or
- The home of a family member (after having been certified by a physician as (1) being no longer able, for medical reasons, to live independently, and (2) requiring assistance with instrumental or other activities of daily living).

An older tenant can terminate the lease and move into one of the above alternative living arrangements by notifying the landlord/owner/lessor. The notification must:

- Be made in writing and signed by the tenant (or tenant's legal representative);
- Delivered to the owner or the owner's agent; and,

• Include documentation showing he has been notified that he can now move into one of the alternatives above; or, if moving in with a family member, include a physician's certification that he meets the health-related requirements to live with a family member, as well as the family member's documentation that he/she is related to the tenant and that the tenant will live with them for at least six months.

The termination will take effect 30 days after the day upon which the next rental payment is due and payable.

Section 227(a) of the Real Property Law also imposed the following penalties upon the landlord if he or she does not comply:

If anyone interferes with the removal of your property from the premises, they will be found guilty of a misdemeanor and will be either imprisoned for up to one year or fined up to \$1,000 or both.

# **Ulster County Adult Care Facilities: An Overview**

The following information has been provided by the New York State Department of Health, which licenses and supervises adult care facilities that provide temporary or long-term, non-medical residential care services to adults who are substantially unable to live independently. Resident dependence may be the result of physical or other limitations associated with age, physical or mental disabilities or other factors.

- Residents of adult homes, enriched housing and assisted living programs are provided with personal care and services on a long-term basis.
- Residences for adults provide long-term residential care with supervision but without personal care.

Most residents of adult care facilities are in need of supervision and personal care services necessary to enable the resident to maintain good personal health and hygiene, to carry out the basic activities of daily living, and to participate in the ongoing activities of the facility.

Personal care includes direction and assistance with grooming (including care of hair and ordinary care of nails, teeth and mouth); dressing; bathing; walking and ordinary movement from bed to chair or wheelchair; eating; and assisting with self-administration of medications.

However, residents of adult care facilities must not require the continual medical or nursing services provided in acute care hospitals, in-patient psychiatric facilities, skilled nursing homes or health related facilities, since adult care facilities are not licensed to provide any nursing or medical care.

Under New York State law, no person or organization may operate an adult care facility without an operating certificate from the Department of Health. Operating certificates are issued only to operators who satisfactorily demonstrate good character, competency and the ability to operate facilities in compliance with law and regulations.

Facilities are subject to periodic inspection by state staff to determine if the facility is being operated in a manner that protects the health, safety and well-being of the residents. Failure of an operator to comply with regulations may result in fines or action to revoke or suspend the operating certificate.

The following definitions will assist you to understand the kind of facility and the service it is licensed to provide.

- AH Adult Home: An Adult Home is established and operated for the purpose of providing long-term residential care, room, board, housekeeping, personal care and supervision to five or more adults unrelated to the operator. Adult homes may be operated by an individual, a partnership, a not-for-profit corporation, a public corporation, a non-publicly traded business corporation or a limited liability company.
- ALP Assisted Living Program: An Assisted Living Program, which is available in some Adult Homes and Enriched Housing Programs, combines residential and home care services. It is designed as an alternative to nursing home placement for individuals who historically have been admitted to nursing facilities for reasons that are primarily social, rather than medical in nature. The operator of the assisted living program is responsible for providing or arranging for resident services that must include room, board, housekeeping, supervision, personal care, case management and home health services.
- EHP Enriched Housing Program: An Enriched Housing Program is established and operated for the purpose of providing long-term residential care to five or more adults, primarily persons sixty-five years of age or older, in community-integrated settings resembling independent housing units. The program provides or arranges for the provision of room, board, housekeeping, personal care and supervision. Enriched Housing Programs may be operated by an individual, a partnership, a not-for-profit corporation, a public corporation, a non-publicly traded business or a limited liability company.
- NFP Not For Profit: NFP is defined as a (Not For Profit) Adult Care Facility.

- **PPHA Private Proprietary Home For Adults:** PPHA is defined in state regulations as an adult care facility which is operated for compensation and profit.
- **RESIDENCE Residence For Adults:** A residence for adults is established and operated for the purpose of providing long-term residential care, room and board; housekeeping and supervision to five or more adults, unrelated to the operator.
- <u>Services for Nonresidents:</u> Services for nonresidents in adult homes, residences for adults and enriched housing is an organized program of services which an operator is authorized to provide to residents of the above facilities but which are provided to nonresidents who are aged or disabled to enable such persons to remain in or return to the community. These services may include an organized social day care program, temporary residential care, or other services the facility is authorized to provide.

In this section of the *Guide*, there are four categories of facilities. You will be able to determine what level of care is provided in each of the categories. It is recommended that, if possible, you tour the facility in person prior to placement.

The first category is <u>Licensed Adult Homes</u>, which are suitable for those with minimal health care needs. These are generally private pay facilities.

<u>Assisted Living</u> facilities are able to provide more structured health care, and can accommodate persons who require support services. It is important to verify if the specific needs of the individual can be met. These facilities may be partially Medicaid funded.

<u>Nursing Homes</u> provide the most structured health care, and may be Medicaid, Medicare, Private Pay or third-party insurance funded.

<u>Hospice Care</u>, which can be provided either in the home, at a nursing home, or in a special unit at Benedictine Hospital, is a comprehensive care plan for the terminally ill. Most health insurance, including Medicare and Medicaid, cover the cost.

### Service category: Nursing Homes Overview

The New York State Department of Health has established the following requirements for Nursing Home Operating Certificates:

**Baseline Services:** Those services included in the daily rate. At the time of admission, a written copy of the following basic services must be made available to all residents:

- the daily, weekly or monthly rate
- board, including therapeutic or modified diets, as prescribed by a doctor.
- lodging a clean, healthful, sheltered environment, properly outfitted.
- dietary services
- 24-hour-per-day nursing care
- pharmacy services
- diagnostic services
- the use of all equipment, medical supplies and modalities used in the care of nursing home residents, including but not limited to catheters, hypodermic syringes and needles, irrigation outfits, dressings and pads, etc.
- fresh bed linen, as required, changed at least twice weekly, including sufficient quantities of necessary bed linen or appropriate substitutes changed as often as required for incontinent residents
- hospital gowns or pajamas as required by the clinical condition of the resident, unless the resident, family member or designated representative elects to furnish them, and laundry services for these and other launderable personal clothing items
- general household medicine cabinet supplies, including but not limited to nonprescription medications, materials for routine skin care, dental hygiene, care of hair, etc., except when specific items are medically indicated and prescribed for exceptional use for a specific resident
- assistance and/or supervision, when required, with activities of daily living, including but not limited to toileting, bathing, feeding and assistance with getting from place to place
- services, in the daily performance of their assigned duties by members of the nursing home staff assigned to resident care
- use of customarily stocked equipment, including but not limited to crutches, walkers, wheelchairs or other supportive equipment, including training in their use when necessary, unless such items are prescribed by a doctor for regular and sole use by a specific resident
- activities program, including but not limited to a planned schedule of recreational, motivational, social and other activities together with the necessary materials and supplies to make the resident's life more meaningful
- social services as needed
- physical therapy, occupational therapy, speech pathology services, audiology services and dental services, on either a staff or fee-for-services basis, as prescribed by a doctor, administered by, or under the direct supervision of a

licensed and currently registered physical therapist, occupational therapist, speech pathologist, qualified audiologist or registered dentist.
